# ABSTRACT

The method used in this research is descriptive qualitative and research data collection uses Robert Stanton's character theory by the words, behavior, conversation and action from film Lolita 1997. The study found that changes in the case take place in three stages. The first stage is the initial character when the character has not been exposed to the triggers that become part of the story's conflict. The second stage is the transition that is generally described as an emotional change based on triggers that have occurred throughout the film. Previous relevant research was conducted by Tesa Helly Rondonuwu (2020) who researched "Characterization Analysis of the Main Character in the Film Barbie of Swan Lake (2023)", then Yolenta Oktovia Mahuze (2021) who researched "Character Analysis of the Main Character in the Film A Street Cat Named Bob by Rogers Spottiswoode" and Sri Mulyati (2020) who researched "Character analysis of Andrea Hirata in the film The Devil Wears Prada based on a Humanistic approach.

The three previous researchers and the research carried out by the current researcher have something in common, namely that they both examined the character of the main character in a film, meanwhile what differentiates previous research is the source of the data. In previous research, research examined the character of the main character, while research conducted by researchers at this time examined the character of the main character by focusing on changes in the character of the main character due to several factors such as emotionality caused by pressure and encouragement from the environment.

# **RESEARCH METHODS**

In this study, the method to be used is a qualitative descriptive study method. The data used in the study is based on a film entitled Lolita 1997 whose object of research is a main character named Humbert.

This data presentation is from a Lolita 1997 movie cut to a few scenes that have been reduced to a character. Data that has been analyzed combined, to which conclusion is obtained.

The data-gathering technique in this study uses the character development theory of Robert Stanton that is according to the words of characters, characters' behavior, character conversations, and character actions. Researchers watch, take notes, and process research materials. As for the data collection step in this study:

1. The writer watches Lolita 1997 to gain insight and knowledge about the character characterization of the main character, to read research, and to the e-journal that addresses character analysis.

2. Collecting data by identifying the parts of the movie in the part of the scene that portray the character of the main character by carefully watching the scenes in the movie collect data by identifying the parts of the movie as part of the scene by carefully watching the events in the movie and understanding the meaning of the event.

3. The listen and note method are done by listening and watching the Lolita 1997 movie. Next, a notepad is carried out using a notepad technique. A note-writing technique is used to record the duration and dialogue in the movie that shows Humbert characters

4. The documentary uses a soft copy of Lolita's movie, which was downloaded from the web site, and then researchers determine scenes that show Humbert character and make screen captures that are the focus of research.

#### THEORETICAL REVIEW

Character terms according to Roberts Stanton in his book an introduction to fiction (1965:17) can refer to individuals in a story or in other words character or story also refer to the union of interests, emotions and moral principles that make up character or in other words describe the behavior or nature of the story. In analyzing the character, Stanton says the most important are dialogue and behavior. In good fiction, every word, action not only sets the grooves but also a manifestation of character (1965:18)

According to Roberts Stanton in his book an introduction to fiction (1965:17) character terms can refer to individuals in a story or in other words character or story also refer to the union of interests, emotions and moral principles that make up character or in other words describe the behavior or nature of the story. Analyzing the main character of Stanton's research categorizes several ways:

1. The writer's words open up insight into character to the reader through the words of the character. The writer presents several clues about character when character speaks, or character in words with others as well as whenever character expresses his or her opinion.

2. The conduct of the character writer may portray the behavior of a person such as traits, habits, or peculiarities that may also inform the reader of something from the main character

3. Conversations between character writers can give some indication of a person's character by speaking to others and things they say also when people talk about others, things they often say about a person's character when speaking.

4. The writer's actions give clues to the reader about one's character by describing to the reader how one reacts to certain situations and conditions. Based on understanding of character according to some experts above, it can be deduced that character is the real trait between the values and the thoughts that become the person's mental attitude.

Wellek and Warren (1977) give insight that the developing characterization is having permanent changes in a variety of areas, such as personal and emotional action. This gets really strengthened by Lajos Egri (1946). He says that character changes through conflict, conflict starts with a decision. The character decision will move other decisions, from the opponent of the character. These decisions, which result from one to the other, push into proof premise.

Edgar V. Roberts (1983) suggests that character in literature is a vast oral representation of humans, especially in determining themselves thought, speech, and behavior. The theory clearly states that dialogue, action, and comment represent a verbal representation of a human or have the most important literary dominance to create some interaction of the characters around them. By definition of character, the writer attempts to analyze the character of the individual-the character in the study by using the theory of Edgar V. Roberts in the same book that says there are four ways to analyze the character, that is, through what the character says about himself, what the character does, what the characters say-others about the character they analyze and what the author says about the character.

# **RESULTS AND DISCUSSION**

The early character Humbert when the character has not been exposed to conflict the story has 4 characterization: Patient, Imaginative, Quiet and Shrewd.

The Humbert characterization analysis from the beginning to end scene shows there are several characterization differences in each scene. The difference in this characterization reflected changes in characterization and this proved that the Humbert character had a characterization change in motion pictures. Here are characterization of Humbert before being exposed to the triggers that are part of the story's conflict:

# 1. Shrewd

Shrewd is an adjective, which means that it describes nouns. The word shrewd has interesting origins, revealing how the meaning of words can change dramatically over time. A shrewd person is able to understand and judge a situation quickly and to use this understanding to their own advantage

It's because Humbert fell in love with Lolita since he first saw her and he wants to be near Lolita. Humbert did various things to always be with Lolita, including marrying Charlotte Haze. When Humbert met Charlotte's daughter Dolores Haze. Humbert then calls Dolores Lolita.

In picture 3.1, there is a scene where Charlotte Haze (Lolita's mother) finds a note in Humbert's book which contains Humbert's wild fantasies about Lolita and the reason Humbert married Charlotte was because he wanted to be near Lolita, making Charlotte angry. As luck always favors Humbert, when Charlotte wants to go to the mailbox opposite her house to send a letter about Humbert's behavior, she is hit by a car and dies. Humbert seemed to maintain his attitude in front of the police when he found Charlotte dead.

Almost every time there is an opportunity, Lolita is always mischievous towards Humbert, but Humbert is always patient with Lolita's behavior and there are many scenes of Humbert's behavior, which is very patient with Lolita and loves Lolita very much.



#### Character Change

Character changes in a Figure can be seen from how the character moves along the story. The Humbert character went through a transition phase that shapes him into possessive, manipulative, obsessive and vengeful personality. After Lolita's mother's death, Humbert and Lolita often traveled to various places, stayed in hotels and had illicit relations. Found in different scenes Humbert is described as a different characterization anyway.

Factors affecting the character of the Humbert lead character during the trip with Lolita led to a transition phase and a different character change from the Humbert character before her. Here's his characterization change.

# a. Humbert became Possessive

Being possessive means you're being a little selfish about people or things in your life: you're clinging to them tightly and saying "Mine!" Being possessive isn't a good thing — possessive people are usually insecure and controlling.

Humbert and Lolita then go around the country and live together. They then settled on a college in Beardsley. There Humbert became a teacher and Lolita became a student of a Catholic school. During his life with Lolita, he was so strict about forbidding Lolita to hang out with her peers at school. He also strongly forbade her to have extracurricular activities at the school in school dramas and got them into a big fight.

#### b. Humbert is overly anxious

Anxiety refers to anticipation of a future concern and is more associated with muscle tension and avoidance behavior.

Humbert lied to Lolita about the death of her mother who died from being so sick, he wanted to make Lolita have no one else besides him as her stepfather. The changes Lolita has experienced seem very obvious to Humbert gradually, to say that Lolita is bored with her relationship with Humbert. She wanted to break free like other girls her age. Fearing that Humbert would lose Lolita made him an obsession and become excessively anxious and turned into an aggressive too.

### c. Humbert became a sadistic personality disorder

Sadistic personality disorder was defined by a pervasive pattern egosyntonic sadistic behavior. Individuals possessing sadistic personalities tend to display recurrent aggression and cruel behavior. People with this disorder will use violence and aggression in an attempt to control and dominate others.

When humbert wanted to take Lolita away because he felt that someone was following him, Humbert always experienced anxiety over his relationship with Lolita, even more he realized that Lolita has been uncomfortable and has looked at Humbert as a living nuisance.

The unsteady Lolita often invites arguments with Humbert. Sometimes Lolita is tired and depressed at the thought of being controlled by Humbert. She then went with a man named Clare Quilty who had ill intentions. Clare's a pedophile and a child predator who's far worse than Humbert. Clare likes lolita and targets the girl. He kept trying to get close to her and took her away from Humbert.

When Lolita got tired of Humbert and wanted to feel free, she finally went with Quilty and separated from her stepfather. But it turned out that Quilty wanted to use Lolita and force her to become involved in making a pornographic film. When Lolita refused, Quilty threw her away and didn't care about her anymore.

The scene where Humbert lost Lolita, it moved humbert to look for Lolita everywhere, when Lolita sent a letter to Humbert to help her financially, so quickly helped and met Lolita. After meeting Lolita and seeing her pregnant, he invited Lolita to come back with him but Lolita refused and chose to live with her small family. At this point Humbert is desperate and he's leaving Lolita. Humbert was so angry at Clare Quilty, after he heard Lolita's story, Humbert held a very heavy grudge and blamed Clare for everything that happened to Lolita and him.

At this stage, it forms Humbert to character of vengeance and fury and jealousy when he kills Quilty as a Humbert attempt to bring to justice his revenge which assumes it's all because of Clare



There is a considerable change in character of the Humbert character throughout the film narrative. The change in character in the Humbert character results from such factors as emotional pressure and encouragement from the environment, situations and conditions that occurred and the events that occurred to Humbert from the actions of another character especially in the conflicts that began when Lolita met with another man named Clare Quilty a drama writer. Lolita went with Quilty and made Humbert miserable to find her.

The transition in the case takes place through three stages. The first stage is the initial character when the character has not been exposed to the triggers that become part of the story's conflict. The second stage is the transition that is generally described as an emotional change based on triggers that have occurred throughout the film. The third stage is a final character change that generally has significant change from the initial character.

The early Humbert character who walks at the scene has characters that are patient, imaginative quiet and shrewd as its time goes. Humbert experiences a transition phase that shapes him into a possessive, erratic and overanxious personality, as a result of the conflict that results from the disturbed Humbert's fear of losing Lolita, sparked by the terauma past the Humbert that his girlfriend lost when he was a teenager, it is what influences the change in character of the Humbert lead character. The Humbert phase of change character that became tarnished when he learned of Lolita, that Lolita escaped with Clare and he tried to sell Lolita.

The development of Humbert is seen developing from good to bad. Thus, the Humbert takes on a variety of character changes influenced by the pressures and impulses of the environment
